TRADE CONDITIONS 2023 TAMWORTH SHOW

1. Please ensure all information is enclosed in the application as incomplete applications will not be considered for site allocation.
2. Applications for a Trade Space fee must be paid by the 14th February 2023
3. Cancellations – refund will only be accepted if cancellation is week out from the show. Cancellation the morning of first day no refund.
4. Public Liability Insurance - A copy of a current insurance cover must be returned with this forms
5. Trade space is allocated in lots of three (3 x 5) metre to allow covid space so you are not right up against the next door trader
6. Electrical connections
 - a. All Trade Stall Operators intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a competent person to standard AS/NZS 3760: 2010. This is a requirement of the Work Health and Safety Act 2011 (NSW). Please check all your electrical equipment and leads before you arrive to ensure adherence with these conditions.
 - b. All electricity leads are to be appropriately covered or elevated across traffic areas
7. Stall owners and operators are required to comply with Work, Health and Safety (WHS) laws and have in place their own WHS policy and safe systems of work for their activities. All exhibitors must conduct a risk assessment on the equipment or exhibit activities that they will be undertaking during the Show and provide a copy of the risk assessment on request to the Trade Steward.
8. Displays must not be dismantled or removed before 3.00pm on the Sunday of the Show without the permission of the Trade Steward.
9. All areas must be left clean and rubbish placed in industrial waste bins located at designated areas on the grounds, not in the small individual rubbish bins intended for general waste collection.
10. The display of advertising materials is restricted to the area occupied by the space holder.
11. Gambling and the sale of raffle tickets is strictly prohibited unless approval in writing has been provided by the Tamworth P&A Association Inc. and other appropriate permits are held where required.
12. Vehicles will not be permitted access to the pedestrian areas of the ground after 7.30am Friday. All stallholders are requested to organize deliveries prior to this time and notify your suppliers of this condition.
13. The Tamworth Show Society Inc. will attempt to minimise the duplication of trade stalls of the same goods and/or services as we encourage a diversity of vendors, however the Tamworth P&A Association Inc. does not provide exclusivity.
14. This document does not constitute an offer but is issued only to solicit proposals. The Tamworth P&A Association Inc. reserves the right to reject any proposals and its decision will be final. The Tamworth P&A Association Inc. is not required to enter into any correspondence regarding reasons for non-acceptance of any application.

I acknowledge that I am responsible for ensuring the safety of Tamworth Show patrons and their property;

1. I agree to indemnify the Suppliers., their Officers, Committee Members and/or their Agents in respect of bodily injury to myself or any person or damage to property caused or contributed to by my acts or omissions or by my animal(s), except as might be covered by any specific insurance taken out by me or on my behalf to cover such liability;
2. I acknowledge and agree that my participation in the Event and associated activities is a danger and may have inherent risks as a result of which personal injury (and sometimes death) may occur. I accept and assume all such risks of personal injury or death in anyway whatsoever arising from these activities and hereby waive my individual right to sue the Suppliers for all claims I or my representatives may have for such personal injury or death against the Suppliers in any way whatsoever arising from or in connection with these activities;
3. I acknowledge that I am required to hold a current policy of insurance covering all my personal property, including equipment, machinery and stock, and the Suppliers will not take out such insurance on my behalf;

4. If I suffer injury, loss or damage (Loss) while participating in the Event, I will not hold the Suppliers, their employees or agents legally responsible for any Loss I suffer. I will not sue the Suppliers, their employees or agents for any claims, costs, damages or liability;
5. I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in;
6. I agree that participation in the Event requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the Event;
7. I am responsible for ensuring that I have and will wear equipment suitable for safely and properly participating in the Event;
8. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event;
9. I use the facilities supplied for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me;
10. I acknowledge that part of the Event is held outdoors and that there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;
11. I will not consume any alcohol or illicit drugs while participating in the Event and agree that such use may result in my being excluded from the Event or other events with no entitlement to any refund of money paid for entry to the Suppliers;
